OMCs: Industry volumes rose 4.3% YoY in Mar-24, 9MFY24 decline now stands at 11.4%

The OMC industry saw a 4.3% YoY growth in Mar-24, with total volumes reaching 1,153.1 K tons. This contrasts with a 11.4% decline in volume over the first nine months of FY24, totaling 11,337 k tons. Motor Spirit (MS) and High-Speed Diesel (HSD) volumes increased by 2.6% and 16.6% YoY, respectively, while Furnace Oil (FO) experienced a significant decline of 48.2%, reflecting a shift in consumption patterns.


Industry: YoY growth in Total Volumes





PSO: Volumes rose 11.0% YoY in Mar-24, 9MFY24 volume decline now at 12.5%

Pakistan State Oil (PSO) recorded a volume of 594.5 K tons in Mar-24, showing an 11.0% increase YoY but faced a 12.5% decline over 9MFY24, with total volumes at 5,670.8 K tons. Despite robust gains in MS and HSD segments, PSO's performance was affected by a substantial decrease in FO sales.




PSO: YoY growth in Total Volumes



SHEL: Volumes rose 5.6% YoY in Mar-24, taking 9MFY24 volume decline to 16.3%

Shell Pakistan (SHEL) achieved Mar-24 volumes of 94.2 K tons, a 5.6% YoY increase. However, the company observed a 16.3% decrease in volume for 9MFY24, totaling 826.3 K tons. SHEL mirrored the industry's pattern with stable performance in MS and HSD in Mar-24. However, SHEL witnessed much higher declines in MS and HSD during 9MFY24.






APL: Volumes declined 8.8% YoY in Mar-24, taking 9MFY24 volume decline to 4.0%

Attock Petroleum Limited (APL) reported a decrease in volumes by 8.8% YoY to 103.4 K tons in Mar-24, with a 4.0% decline in volumes for 9MFY24, reaching 1,148.0 K tons. Despite downturns, APL showed resilience in the MS and HSD against broader industry pressures, with MS and HSD volumes rising by 2.9% YoY during 9MFY24.




APL: YoY growth in Total Volumes



HASCOL: Volumes declined 40.8% YoY in Mar-24, taking 9MFY24 Volume growth to 8 6%

HASCOL faced a significant 40.8% YoY decline in Mar-24 volumes, down to 25.5 K tons, but saw an 8.6% increase in 9MFY24 volumes, amounting to 278.4 K tons.

CYNERGICO: Volumes rose 74.7% YoY in Mar-24, taking 9MFY24 volume growth to 9.1%





Valuation Methodology

To arrive at our 12-months Price Target, the JV uses different valuation methods which include: 1). DCF methodology, 2). Relative valuation methodology, and 3). Asset-based valuation methodology.
